FROM THE DIRECTOR:

Dear NHCC Supporters,

It has been a busy year! During the fiscal year (July 2017-June 2018) we served 593 individuals through our direct services programs—providing 5,605 services to these individuals. We also provided 97 community education and awareness activities reaching 2,627 participants and 16 professional trainings/presentations reaching 420 professionals through our prevention and professional education efforts.

As I reflect on our challenges and successes this past year, I am reminded how much we have achieved; yet there is still much to do. As a victim advocacy movement, and an agency, we have made strides in better understanding and responding to crime and victimization. Though we have also recently been reminded by sexual assault victims, through things like #MeToo and media reports (e.g. *the Star Tribune*'s "Denied Justice: When Rape is Reported and Nothing Happens," etc.) that we, as a community,

have let victims down. NHCC does not believe that this inadequate and unjust response is only relevant to sexual assault victims—we know that there are gaps in effective responses to all types of crime.

NHCC believes that there is great value in negative feedback, as it provides insight on needs and gives guidance to the path for growth and opportunity for positive change. We consider this a call to action—and we will step up to meet the needs of victims in our communities!! We will review our protocols, responses, and accountability measures—and make necessary adaptions. We will encourage our criminal justice partners to do the same. We will work together—to ensure a comprehensive, effective response to all crimes!

We appreciate your continued support as we stand with victims! Together—we will make meaningful change!

Everyone who lives and breathes faces a crisis at one point or another. Sometimes, the burden is too great to bear alone. New Horizons Crisis Center (NHCC) is here to help victims/survivors of crime in any way we possibly can. Crisis is personally defined; no problem is too great or too small for us to take your call. We will listen, judgement free. We can help find the resources and individual needs to move forward. 24 hours a day– 7 days a week– 365 days a year, we are here for anyone and everyone.

When someone is a victim/survivor of crime and they are not sure where to turn; New Horizons Crisis Center's 24-hour crisis line is an available resource. The crisis line is a vital link to agency services as well as community resources and referrals. Staffed by volunteers, the crisis line is answered when the agency offices are closed. New Horizons Crisis Center's crisis line volunteers come from all walks of life; college students and community members alike. Volunteers can come from the NHCC service area of Lincoln, Lyon, Murray, and Redwood counties.

We have recently updated our training to be flexible with computer-based components. This is a less intensive training schedule as much of the training can be done on your own time and at your own pace. HAVE YOU HEARD ABOUT S.M.A.R.T? Sexual –Assault Multidisciplinary Action Response Team

Earlier this summer, the Minneapolis Star Tribune released the first in a series of articles, "Denied Justice: When Rape is Reported and Nothing Happens" in which some of Minnesota's victims/survivors of sexual assault courageously shared their experiences. This has started a statewide public conversation about sexual assault and our justice system. While the stories being told are from victims/survivors that live in another part of the state, we know that experiences like these happen in every county across the state of Minnesota. The Lyon County SMART has taken this opportunity to open up dialogue within the Team about looking at our system's response and ways to make meaningful chanae.

Lyon County SMART was formed in 2009 with the mission of creating and implementing a multiagency response to meet the specific needs of individuals who experience sexual assault and to better achieve justice and healing. A protocol was created to be followed by each responding agency to provide a more victim -centered approach toward sexual assault crimes. Our team works together to continually assess, improve, and evaluate the overall response. Lyon County SMART recognizes the responsibility we have in playing an active role in responding to experiences like those relayed in the Denied Justice series. We want to be intentional about ensuring that our response is informed by the real life experiences and feedback of victims.

We acknowledge that this is a systematic criminal justice issue and that accountability at every level is necessary. We are not going to shy away from hearing these stories. We will use our collaborative and multidisciplinary approach to highlight these challenges and use them as a catalyst for improvements that might need to be made. Our goal is to ensure the criminal justice system is helpful, effective resource for survivors of sexual assault. Listed below are some of the starting points that will be guiding our conversation and work over the course of upcoming months.

- We will acknowledge reactions
- We will recognize the existing
- realities
 We will recognize that relationships are essential in addressing apps
- We will recognize responses that are being done well in Lyon County
- We will be accountable

I have been working my way through Murray and Lincoln Counties meeting with Law Enforcement, County Attorneys, and schools promoting services, Law Enforcement Victim Information Cards, and education opportunities. I have also gotten a lot of interest from members of the communities to present some of the education opportunitie

I am overjoyed at the amount of people that have reached out. Three of my upcoming education opportunities are presenting FLASH Curriculum (published by Seattle & King County Public Health) to high school students, a Safe Body presentation for one of the local churches, and also a Sexual Assault Exam Training that will be presented by Linda Walther and Jude Foster from Minnesota Coalition Against Sexual Assault (MNCASA). The Sexual Assault Exam Training is free and open to all medical professionals and also students that are working to become medical professionals. The training is on September 26th and will include many topics such as:

- Overview of sexual assault
- Working effectively with advocates
- Role of the healthcare professional
- Interview techniques
- Evidence collection
- Injury identification
- Review of anatomy Documentation
- STI Prophylaxis and Emergency Contraception
- Case studies with an opportunity to practice evidence collection

PARENTING TIME

New Horizons Crisis Center continues to provide a much needed service through our Parenting Time Program. Through supervised visits and safe exchanges, children are able to visit their noncustodial parents in a safe setting, as well as experience exchanges between parents without conflict.

The Parenting Time (PT) Program has continued to see a lot of growth over the past few years. During the 2017-2018 fiscal year, there were a total of 1,821 supervised visits scheduled, which included a total of 162 children visiting at our locations.

Through an Otto Bremer Trust grant the PT Program was able to create and hire for a new Parenting Time Program Coordinator position. The PT Coordinator will help with the various day to day operations of the program which will help to speed up the intake process for new families entering the program as well as the daily scheduling needs. We are happy to wel-

Hello! My name is Desiree and October will mark 1 year since I began my journey as the Redwood County Program Coordinator and Community Primary Prevention Partnerships (CPPP) Coordinator with New Horizons Crisis Center (NHCC). What a year it's been! When I decided to take a step back from a 17 year career in the health care field and come on board with NHCC, I had no idea that this new position would create an even bigger investment in my community and passion for serving others.

My advocacy work in Redwood County has taught me so much about the strength and resiliency that victims/ survivors have. It is our wish that nobody finds themselves a victim of a crime,

however, knowing that I can be there to advocate and support them when they are is fulfilling and gives hope that someday our world will be a better place. NHCC's mission to provide counties we serve with education and prevention does not only align with my personal goals but has helped me discover that I am not as

shy as I thought I was. In March, I was invited to present Body Safety education to Cedar Mountain Elementary students. Students K-5 eagerly took part in this fun presentation! It is important that our children are given the tools and education to understand their right to be respected and to be safe from harm. The 2018-2019 school year at Redwood Valley Middle School will be the 3rd year that NHCC is able to present 8th graders with the Safe Dates curriculum provided through a CPPP grant from Minnesota Coalition Against Sexual Assault (MNCASA). Even more exciting is that this year I will also be presenting Safe Dates to the 8th graders at Red Rock Central School for the first time! Safe Dates equips students with the skills needed to take part of healthy relationships and to be able to identify unhealthy relationship signs. It also teaches them to communicate effectively and develop healthy habits. This is knowledge that they can expand on to carry them through some of their toughest years and help them become healthy adults.

A major role at NHCC is to protect and advocate for victim's rights. I was excited to work with Kris Garman at Redwood Area Hospital (RAH) to create a policy within the ER department that would allow a victim to receive treatment for a sexual assault without having to report to law enforcement before they were ready. This is an important right that a victim has after an assault and allows the victim to choose when and how to share their victimization while still protecting important evidence for when/if they do report. Once the policy was developed, I was invited to a staff meeting to educate the medical staff about restricted/unreported sexual assault exams. The nurses at RAH proved to be compassionate and eager to learn as much as possible so they can provide the best care to the patients.

My community is important and it is with that investment that I have been dedicated to strengthening my community partnerships. I am truly honored to serve Redwood county alongside the dedicated Law Enforcement agencies, County Attorney's Office, Restorative Justice Department, medical professionals at RAH, and the amazing advocates at Minnesota Indigenous Women's Society and WoMen's Rural Advocacy Program (WRAP). It is because of these people and organizations that contribute to making Redwood County a great community, that I am grateful to live, work, and raise my children in.
